### 1. Purpose:

The purpose of the following document is to define the general policies and criteria followed in the administration of probation for graduate students in the Industrial Engineering Department.

### 2. Scope:

This procedure applies to both new and continuing IE graduate students and faculty, and addresses such issues as placement on probation, terms of probation, removal of probation, graduation, and appeals.

### 4. Policy and Criteria:

**Note 1:** The probationary status of graduate students in Industrial Engineering is administered by the Graduate Policy and Exams Committee (GPEC).

#### 4.1 **Placement on Probation**

- a. **New Students:** An applicant for graduate study in Industrial Engineering who does not meet the normal requirements for admission may be recommended for *admission on probation* by the Department.
- b. **Continuing Students:** Students previously admitted for graduate study in Industrial Engineering will be placed on probation if they fail to make *satisfactory academic progress* as defined by current Department policy. (See IEP 11.1 - **Criteria for Satisfactory Academic Progress as a Graduate Student in Industrial Engineering**)

#### **4.2 Term of Probation**

- a. The probationary status of each student will be reviewed at the end of each regular semester. A student placed on Probation who fails to qualify for removal of probation at the next review of his or her probationary status will not be permitted to continue graduate studies in the IE Department.

#### **4.3 Removal of Probation**

4.3.1 A student will be removed from probationary status under the following conditions:

- a. A student admitted on probation will be removed from probation if that student:
  - i. Has met all special conditions specified in the letter from the Graduate School notifying the student of admission AND
  - ii. Is making satisfactory academic progress according to the Department's current policy. (See IEP 11.1 - **Criteria for Satisfactory Academic Progress as a Graduate Student in Industrial Engineering**)
- b. Continuing students on probation will be removed from probation if they are deemed to be making satisfactory academic progress by current Department policy.
- c. A student may be removed from probation by special action of the GPEC.

#### **4.4 Graduation**

- a. A student will not be recommended for a graduate degree in Industrial Engineering while on probation.

#### **4.5 Appeals**

- a. Decisions made by the GPEC can be appealed to the Department Committee.
